The NL Housing & Homelessness Network's Board of Directors is made up of volunteers who provide leadership and commitment to the delivery of our mandate to address housing and homelessness challenges in rural and remote Newfoundland and Labrador, and advocate for ways forward.

Members of the Board are responsible for providing overall direction to the NL Housing & Homelessness Network, including review and approval of NLHHN's strategic objectives, policies, and finances. The Board is supported by NLHHN's Executive Director and staff.

Our goal is to bring on new board members who are committed to working collaboratively on issues relating to housing and homelessness, addressing unique rural and remote challenges, and supporting the needs of those who are housing insecure or homeless in Newfoundland and Labrador.

We are looking for new board members and accepting expressions of interest. Applicants will be reviewed by the current NLHHN Board before being invited to attend meetings and stand for election by the general membership at the Annual General Meeting.

Time Commitment & Travel

Directors serve for a three-year term, with the possibility of serving a second consecutive term, and are expected to attend:

- Monthly one-hour meetings of the Board of Directors are held virtually.
- NLHHN's Annual General Meeting, held in person in the Fall.

There is no compensation associated with this position. Directors are reimbursed for travel, accommodation and meal costs associated with attending NLHHN in-person meetings and other authorized business. Meetings are held on weekdays.

Expectations & Responsibilities

Directors provide proper financial oversight by reviewing financial statements and ensuring proper financial controls are in place. Directors are expected to use due diligence in reviewing and approving financial and legal documents.

Directors are expected to enhance NLHHN's work and community outreach by actively cultivating partnerships and facilitating community connections.

Directors help to identify and recruit new board members, assess board performance, and are required to contribute to a positive board environment through respectful discussion.

Directors will serve on several committees, which include Finance, Human Resources, Communications, and/or The Network Café Board of Directors.

Qualifications

NLHHN's Board of Directors should represent the broad range of expertise, projects, and services the NLHHN delivers, and should represent the variety of communities and organizations we serve. - Experience living in rural and remote Newfoundland and Labrador.
- Knowledge and understanding of the community sector and non-profits organizations.
